Temporary Suspension of Securities Trading
Sanctions for the Submission of Annual Audited Financial Statements as of 31 December 2025
For Listed Companies on the Main Board and Development Board

In relation to the obligation to submit the Annual Audited Financial Statements as of 31 December 2025 for Listed Companies whose shares are listed on the Main Board and Development Board, and pursuant to Provision II.6.3. of Exchange Regulation No. I-H concerning Sanctions, the Exchange has imposed Written Warning III and a fine of IDR150,000,000.00 on Listed Companies that have failed to fulfill such obligation to submit the Financial Statements and/or have failed to pay the fine for the late submission of such Financial Statements within the deadline stipulated under the Exchange Regulations.

Pursuant to Provision II.6.4. of Exchange Regulation No. I-H concerning Sanctions, the Exchange shall impose a Temporary Suspension of Securities Trading (Suspension) if, commencing on the 91st calendar day after the expiration of the deadline for the submission of Financial Statements, a Listed Company fails to fulfill its obligation to submit the Financial Statements and/or has submitted the Financial Statements but fails to pay the fines as referred to in Provisions II.6.2. and II.6.3. of Exchange Regulation No. I-H concerning Sanctions.

Based on our monitoring, as of **29 June 2026**, there are **71 (seventy-one) Listed Companies** that have not submitted their Annual Audited Financial Statements as of 31 December 2025 and/or have not paid the fines for the late submission of such Financial Statements, as detailed below:
