Pursuant to the Indonesia Stock Exchange (IDX) Board of Directors Decree No. Kep-00035/BEI/06-2025 regarding Regulation No. I-X on the Placement of Equity Securities Listings on the Special Monitoring Board:

1. For Listed Companies whose Equity Securities had already been designated for listing on the Special Monitoring Board at the time the Regulation came into effect, the calculation of the consecutive one-year period as referred to in Provisions V.1 and V.2 shall commence from the date such Listed Companies were designated for listing on the Special Monitoring Board pursuant to the IDX Board of Directors Decree No. Kep-00076/BEI/06-2024 dated June 20, 2024 concerning the Amendment to Regulation No. I-X on the Placement of Equity Securities Listings on the Special Monitoring Board, effective from June 21, 2024.
2. Provision V.1 stipulates that IDX shall impose a Suspension of Securities Trading on a Listed Company that meets the criteria set out in Provisions III.1.2, III.1.3, III.1.4, III.1.5, III.1.6, III.1.8, and/or III.1.9, provided that such Listed Company has remained on the Special Monitoring Board for more than one consecutive year.
3. Provision V.1 does not apply to Listed Companies that meet only the criterion of reporting negative equity in their latest financial statements as referred to in Provision III.1.5. This exemption remains effective until June 30, 2026.

Furthermore, in order to maintain an orderly, fair, and efficient securities trading market, IDX has decided to:

1. Suspend temporarily of securities trading in All Markets for 19 (nineteen) Listed Companies with active trading status, effective from Session I of the Periodic Call Auction on Wednesday, July 1, 2026.
2. Suspend temporarily of securities trading in the Negotiated Market and maintain the existing temporary suspension in the Regular Market and the Cash Market, thereby resulting in the temporary suspension of Securities in All Markets for 5 (five) Listed Companies, effective from Session I of the Periodic Call Auction on Wednesday, July 1, 2026.
3. Maintain the temporary suspension of securities trading in All Markets for 13 (thirteen) Listed Companies.
