Penghentian Sementara Perdagangan Efek
PT Multi Agro Gemilang Plantation Tbk (MAGP)

1. Pengumuman PT Bursa Efek Indonesia (“Bursa”) No. Peng-SPT-00005/BEI.PP1/07-2022, Peng-SPT-00012/BEI.PP2/07-2022, Peng-SPT-00007/BEI.PP3/07-2022 tanggal 18 Juli 2022 perihal Penghentian Sementara Perdagangan Efek.
2. Surat Bursa nomor S-08659/BEI.PP1/07-2026 tanggal 17 Juli 2026 perihal Permintaan Penjelasan dan Reminder Kewajiban.

Dengan belum adanya perkembangan yang signifikan dari perbaikan yang dilakukan PT Multi Agro Gemilang Plantation Tbk (Perseroan) sehingga memberikan indikasi adanya suatu ketidakpastian material yang dapat menyebabkan keraguan signifikan atas kemampuan Perseroan untuk mempertahankan kelangsungan usahanya.

Berdasarkan hal tersebut, Bursa memutuskan untuk melakukan penghentian sementara perdagangan Efek PT Multi Agro Gemilang Plantation Tbk (MAGP) di Pasar Negosiasi (sebelumnya sudah suspensi di Pasar Reguler & Pasar Tunai *Periodic Call Auction*). Dengan demikian, Efek Perseroan dihentikan sementara perdagangannya di Seluruh Pasar terhitung sejak **Sesi I *Periodic Call Auction* pada Kamis, 23 Juli 2026** hingga pengumuman Bursa lebih lanjut.

Bursa meminta kepada pihak-pihak terkait untuk selalu memperhatikan keterbukaan informasi yang disampaikan oleh Perseroan.

1. Indonesia Stock Exchange (the "Exchange") Announcements No. Peng-SPT-00005/BEI.PP1/07-2022, Peng-SPT-00012/BEI.PP2/07-2022, and Peng-SPT-00007/BEI.PP3/07-2022 dated 18 July 2022 concerning *Penghentian Sementara Perdagangan Efek*; and
2. Exchange Letter No. S-08659/BEI.PP1/07-2026 dated 17 July 2026 concerning *Permintaan Penjelasan dan Reminder Kewajiban*.

Considering that there has been no significant progress in the business recovery efforts undertaken by PT Multi Agro Gemilang Plantation Tbk (the "Company"), which indicates material uncertainty that may cast significant doubt on the Company's ability to continue as a going concern.

Based on the foregoing, the Exchange has decided to temporarily suspend the trading of the Securities of PT Multi Agro Gemilang Plantation Tbk (MAGP) in the Negotiated Market (as trading in the Regular Market and Cash Market under the Periodic Call Auction mechanism had previously been suspended). Accordingly, the trading of the Company's Securities is suspended in All Markets, effective from **Session I of the Periodic Call Auction on Thursday, 23 July 2026**, until further announcement by the Exchange.

All interested parties are advised to continuously pay attention to the information disclosures submitted by the Company.
