Penghentian Sementara Perdagangan Efek atas
Sanksi Penyampaian Laporan Keuangan Interim per 31 Maret 2026

Sehubungan dengan kewajiban penyampaian Laporan Keuangan Interim per 31 Maret 2026 yang Diaudit oleh Akuntan Publik bagi Perusahaan Tercatat yang mencatatkan Saham, serta sesuai dengan ketentuan II.6.3. Peraturan Bursa Nomor I-H tentang Sanksi, Bursa telah memberikan Peringatan Tertulis III dan Denda sebesar Rp150.000.000,00 kepada Perusahaan Tercatat yang belum memenuhi kewajiban penyampaian Laporan Keuangan dimaksud dan/atau belum melakukan pembayaran Denda atas keterlambatan penyampaian Laporan Keuangan dimaksud sesuai batas waktu yang ditentukan dalam peraturan Bursa.

Mengacu pada ketentuan II.6.4. Peraturan Bursa Nomor I-H tentang Sanksi, Bursa melakukan penghentian sementara perdagangan Efek (Suspensi), apabila mulai hari kalender ke-91 sejak lampaunya batas waktu penyampaian Laporan Keuangan, Perusahaan Tercatat tidak memenuhi kewajiban penyampaian Laporan Keuangan dan/atau Perusahaan Tercatat telah menyampaikan Laporan Keuangan namun tidak memenuhi kewajiban untuk membayar denda sebagaimana dimaksud dalam ketentuan II.6.2. dan II.6.3. Peraturan Bursa Nomor I-H tentang Sanksi.

Berdasarkan pemantauan kami, hingga tanggal **28 Agustus 2026** terdapat **1 (satu) Perusahaan Tercatat** yang belum menyampaikan Laporan Keuangan Interim per 31 Maret 2026 yang Diaudit oleh Akuntan Publik dan/atau belum melakukan pembayaran denda atas keterlambatan penyampaian Laporan Keuangan tersebut, dengan rincian sebagai berikut:

Temporary Suspension of Securities Trading
Sanctions for the Submission of Interim Financial Statements as of 31 March 2026

In relation to the obligation to submit the Audited Interim Financial Statements as of 31 March 2026 for Listed Companies whose shares are listed on Indonesia Stock Exchange (“Exchange”), and pursuant to Provision II.6.3. of Exchange Regulation No. I-H concerning Sanctions, the Exchange has imposed Written Warning III and a fine of IDR150,000,000.00 on Listed Companies that have failed to fulfill such obligation to submit the Financial Statements and/or have failed to pay the fine for the late submission of such Financial Statements within the deadline stipulated under the Exchange Regulations.

Pursuant to Provision II.6.4. of Exchange Regulation No. I-H concerning Sanctions, the Exchange shall impose a Temporary Suspension of Securities Trading (Suspension) if, commencing on the 91st calendar day after the expiration of the deadline for the submission of Financial Statements, a Listed Company fails to fulfill its obligation to submit the Financial Statements and/or has submitted the Financial Statements but fails to pay the fines as referred to in Provisions II.6.2. and II.6.3. of Exchange Regulation No. I-H concerning Sanctions.

Based on our monitoring, as of **28 Agustus 2026**, there are **1 (one) Listed Company** that have not submitted their Audited Interim Financial Statements as of 31 March 2026 and/or have not paid the fines for the late submission of such Financial Statements, as detailed below:
